GIST OF THE COMPLAINT:

The complainant consumer Sri Purna Chandra Singh, Repr. by Sri Jugeswar Singh, At- Talbahandra, PO- Belkhandi, Ps- Kesinga, Dist.- Kalahandi comes under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 27.05.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 0.50 KW having consumer no- **9033-1406-0602** under SDO Elect. Kesinga.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill

As written version submitted by SDO Elect. Kesinga as follows:

- Excess billing raised in the month of August 2023 and February 2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that excess billing raised in the month of August 2023 and February 2024.
- As per database the meter no. 8110732 was install during initial power supply which is still continuing.

ORDER

29.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from June 2012 to May 2024 taking IMR "0" as on 06/2012 and FMR "10977" as on 05/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
