GIST OF THE COMPLAINT:

The complainant consumer Sri Dutiya Sahu, Repr. by Sri Hrusikesh Sahu, AT/Po-Rengali, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 14.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- 9033-1408-0581 under SDO Elect. Kesinga.
- 2) As Complained by the complainant that abnormal bill was raised from 08/2023 to 12/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 05/09/2024
- 2) Bill details from December 2009 to July 2024
- 3) Date of supply 30/12/2009
- 4) Category: LT/Domestic



- 6) Meter No TWNX515562
- 7) Installed on 19/01//2024 with IMR: "0"
- 8) CMR: 1902 KwH as on 05/09 /2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Excess billing in the month of 08/2023.
 - Provisional bill not been adjusted from 11/2023 to 12/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Excess billing in the month of 08/2023 and Provisional bill not been adjusted from 11/2023 to 12/2023.
- As per billing database the bill was raised in the month of 08/2023 in 4212 units with IMR "9912" KWH, which seems supress meter reading.
- As per database, one bill revision was done on 08.11.2023 for the period 09/2020 to 08/2023, but not approved in the system this revision needs to be rejected.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill by way of recasting from 09/2020 to 08/2023 taking IMR "0" KWH on 09/2020 and FMR "9912" KWH on 08/2023.
- The bill revision done in system on 08.11.2023, which is not approved yet, to be rejected.
- To revise the bill for the month of 09/2023 and 12/2023 by taking six-month average consumption of present meter (IMR "0" KWH on 01/2024 and FMR "1400" KWH on 06/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
