GIST OF THE COMPLAINT:

The complainant consumer Sri Dolamani Bag, At/Po- Sirol, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 21.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1408-1218 under EE, Elect. Sub-Division Kesinga
- 2) As complained by the complainant that the bills were generated during no supply period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per PVR submitted by JE and officer com. section office Nunmath on dated.28.02.2025, the consumer was availing power supply from 01/2023(date of meter installation) and before that he was not using power supply.
- As per billing database the bills were generated prior to installation of meter on dtd.06.01.2023

ORDER 28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill from 12/2020 to 12/2022 excluding fixed charges as the consumer has not availed the power supply.

The case is disposed of accordingly.
