GIST OF THE COMPLAINT:

The complainant consumer Sri Lalit Mohan Biswal, At- Regdimal, Po/Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 10.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9034-0101-1680** under SDO Elect. Narla
- 2) As complained by the complainant that abnormal excess bill was served in the month of 06/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 24/02/2025
- 2) Bill details from: 04/2006 to 01/2025
- 3) Date of supply: 19/03/2006
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW



- 6) Meter No – TPWODL1117310
- 7) Installed on: 27/10/2022 with IMR “0”
- 8) CMR: 6382 KWH on 24/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As the consumer was billed as suppressed reading, we may recast the bill from 10/2022 to 12/2024 by taking IMR 0 kwh and FMR 6270 kwh and we may cancel the previous bill revision on dated 16/07/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as the consumer was billed as suppressed reading, we may recast the bill from 10/2022 to 12/2024 by taking IMR 0 kwh and FMR 6270 kwh and we may cancel the previous bill revision on dated 16/07/2024.
- As per billing database the actual meter reading submitted vary from 1 unit to 10 units per month from 06/2023 to 05/2024. All of a sudden 4322 units was billed for a month of 06/2024 which seems to be suppressed meter reading.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 10/2022 to 12/2024 by taking IMR “0” kwh on 10/2022 and FMR “6270” kwh on 12/2024.
- To reverse the bill revision on 16/07/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by **March-25** the opposite party after compliance otherwise it will be treated as non-compliance.
