GIST OF THE COMPLAINT:

The complainant consumer Sri Harisankar Naik, At- Kalakupa, Po/Ps- Biswanathpur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 10.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.05 KW having consumer no- **9034-0192-2108** under SDO Elect. Narla
- 2) As complained by the complainant that abnormal excess bill was served in the month of 07/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 24/02/2025
- 2) Bill details from: 12/2019 to 01/2025
- 3) Date of supply: 10/08/2019

- 
- 4) Category: LT/Domestic
 - 5) Connected Load 0.05 KW
 - 6) Meter No – TWB151518
 - 7) Installed on: 20/07/2024 with IMR “0”
 - 8) CMR: 516 KWH on 24/02/2025
 - 9) The meter status: OK
 - 10) Facts of the complainant: Revision of bill
 - 11) As written version submitted by SDO Elect. Narla as follows:
 - As the consumer was billed as suppressed reading, we may recast the bill from 08/2019 to 01/2023 by taking IMR 0 kwh and FMR 4150 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as the consumer was billed as suppressed reading, we may recast the bill from 08/2019 to 01/2023 by taking IMR 0 kwh and FMR 4150 kwh.
- As per billing database the meter was installed from the date of supply but the provisional bill was served for several months due to premises locked, but in the month of 07/2022 2468 units was billed for a month which seems to be suppressed meter reading.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To recast the bill from 08/2019 to 01/2023 by taking IMR “0” kwh on 08/2019 and FMR “4150” kwh on 01/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
