The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 17.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- 9034-0201-0667 under SDO Elect. Narla
- 2) As complained by the complainant that abnormal excess bill was served in the month of 12/2018 and 10/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:


To revise the excess bill.

 - As the suppressed units was billed, we may recast the reading from 01/2017 to 12/2024 as IMR 0 kwh and FMR 14900 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as the suppressed units was billed, we may recast the reading from 01/2017 to 12/2024 as IMR 0 kwh and FMR 14900 kwh.
- As per billing database the meter reading for the month of 12/2018 and 10/2021 was 1771 units and 2804 units respectively, it seems to be suppressed meter reading

ORDER 28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 01/2017 to 12/2024 by taking IMR "0" KWH on 01/2017 and FMR "14900" KWH on 12/2024.
