GIST OF THE COMPLAINT:

The complainant consumer Sri Jagarnath Gahir, Repr. By Sri Subash Gahir, At/Po-Rupra Road, Ps-Narla, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 13.09.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9034-0201-1428 under SDO Elect. Narla.
- 2) As complained by the complainant that the bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 18/09/2025
- 2) Bill details from: 02/2001 to 08/2025
- 3) Date of supply: 01.01.1990
- 4) Category: LT/Domestic
- 5) Connected Load: 1 KW
- 6) Meter No – TWST15102056
- 7) Installed on: 29.05.2025 with IMR "0"
- 8) CMR: 1030 KWH on 18/09/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by ESO, Biswanathpur the present CMR of the consumer is 1030 Kwh on dated 18.09.2025. the defective bill from 12/2019 to 11/2021 may be revised by taking average from 12/2021 to 08/2024 as IMR '0" Kwh and FMR "7781" Kwh.



However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by ESO, Biswanathpur the present CMR of the consumer is 1030 KwH on dated 18.09.2025. the defective bill from 12/2019 to 11/2021 may be revised by taking average from 12/2021 to 08/2024 as IMR '0" KwH and FMR "7781" KwH
- Bill revision already take in place no scope for bill revision.

ORDER

The OP is directed as follows:

➤ As there is no scope for bill revision, the case is hereby dropped.
