GIST OF THE COMPLAINT:

The complainant consumer Maa Devsar Mandir, Durga Mandir Repr. by Sri Rinesh Agrawal, At/Po- Rupra Road, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 17.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 3 KW having consumer no- 9034-0292-0296 under SDO Elect. Narla
- 2) As complained by the complainant that the bill was generated in general purpose category but I have used as domestic purpose.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 20/02/2025
- 2) Bill details from: 09/2024 to 01/2025
- 3) Date of supply: 01/01/2021
- 4) Category: LT/General Purpose
- 5) Connected Load 3 KW



- 6) Meter No AWLT191394
- 7) Installed on: N/A
- 8) CMR: 23085 KWH on 20/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the AOC, Narla the meter is found OK. The supply was using the power supply as domestic category since 01/01/2021.
 - So, we may change the category from com to dom from date of power supply and should revise the bill in domestic tariff.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the AOC, Narla the meter is found OK. The supply was using the power supply as domestic category since 01/01/2021.
- So, we may change the category from com to dom from date of power supply and should revise the bill in domestic tariff.
- The consumer has intimated to SDO that the temporary power supply was taken during the inauguration of temple 16/04/2023 to 23/04/2023 and also taken temporary power supply for Prahary at the temple from 11/04/2024 to 18/04/2024.

ORDER 27.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To change the category from LT/GP tariff to Domestic tariff from the date of supply till date as the consumer utilise the power supply for domestic purpose.
- > The opposite party directed to change the category from LT/GP category to domestic with immediate effect and to serve the bill in domestic tariff.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
