**GIST OF THE COMPLAINT:**

The complainant consumer Sri Dayanidhi Podh Repr. by Sri Hrusikesh Podh, At-Khetupada, Po-Tokarla, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 18.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9034-0293-0158** under SDO Elect. Narla.
- 2) As complained by the complainant that the average bill was served from 06/2016 to 09/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

- As per PVR given by the ESO, Narla the old meter was found defective.

### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR given by the ESO, Narla the old meter was found defective.
- As per billing database the average bill was served from 06/2016 to 09/2022.

### **ORDER**

**31.01.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 10/2020 to 09/2022 by taking six-month average consumption of resent meter (i.e. IMR "0" Kwh on 10/2022 and FMR "43" Kwh as on 03/2023).
- To withdraw the DPS amount from 11/2020 to 03/2023 as it is DOMESTIC category Consumer.

The case is disposed of accordingly.
