GIST OF THE COMPLAINT:

The complainant consumer Sri Prasadi Sahu At/P O- Rinja, Ps- Karlamunda Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Karlamunda on dt.20.02.2024, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 0.04 KW having consumer No 9034-0495-0906 under SDO Elect. Narla.
- 2) As complained by the complainant the fix charges of Rs. 4434/- was levied from 02/2020 to 06/2021 on his Kutir Jyoti scheme line.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the fix charges was levied from 02/2020 to 06/2021.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by SDO Elect. Narla as follows:

• The meter was found defective from 07/2022 to 09/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for withdrawal of fix charges. The OP submitted that the meter was found defective from 07/2022 to 09/2023.
- The bill was already revised from 12/2022 to 09/2023.
- As per retail supply tariff notification the total amount @ Rs. 80/- PM to be levied towards MMFC for Kutir Jyoti Category.

ORDER 05.04.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

As the bill revision/ adjustment has already been considered in the billing database, so no need to revise the bill.

Case is disposed of accordingly. Case is hereby dropped.
