GIST OF THE COMPLAINT:

The complainant consumer Sri Binayak Mahanta, At/Po-Narla Road, Ps-Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 17.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 2 KW having consumer no- **9034-1202-4182** under SDO Elect. Narla.
- 2) As complained by the complainant that he was not staying at his house from 04/2023 to 08/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 19/03/2025
- 2) Bill details from: 03/2015 to 02/2025
- 3) Date of supply: 25.03.2015
- 4) Category: LT/Domestic
- 5) Connected Load 2 KW



- 6) Meter No – TWSP51067511
- 7) Installed on: 02.10.2023 with IMR "0"
- 8) CMR: 4587 KWH on 19/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the ESO, Narla the consumer was not staying at his residence from 04/2023 to 08/2023. so we may withdraw the bill from 04/2023 to 08/2023 (except FC).

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the ESO, Narla the consumer was not staying at his residence from 04/2023 to 08/2023. so we may withdraw the bill from 04/2023 to 08/2023 (except FC).
- As per billing database average bill were served from 04/2023 to 08/2023. the ESO Narla has physically verify the consumer premisses and discuss with neighbouring consumer and found that the consumer was not staying in the house from 04/2023 to 08/2023.

ORDER

29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To withdraw the bill amount excluding the fixed charges from 04/2023 to 08/2023 as the consumer was not staying at home.


The case is disposed of accordingly.

Compliance report must be submitted to the Forum by **April-25** the opposite party after compliance otherwise it will be treated as non-compliance.
