GIST OF THE COMPLAINT:

The complainant consumer Sri Chatura Rana, At- Tulagaon, Po- Sargiguda, Ps-Narla Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 06.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- **9034-1202-4979** under SDO Elect. Narla.
- 2) As complained by the complainant the bill was raised without power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the ESO Narla there is no such meter was available in the consumer premises. It is a double bill and the currently the consumer is using a other connection vide consumer number 9034-1202-4155.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per the PVR given by the ESO Narla there is no such meter was available in the consumer premises. It is a double bill and the currently the consumer is using another connection vide consumer number 9034-1202-4155.
- The Sarapanch Sargiguda GP has sign in witness in the application of Sri Chatura Rana that cons. no- 9034-1202-4979 is not existing in his house.
- As per billing database the provisional/average bill has raised from 02/2021 to 07/2024.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019. The OP is directed as follows:

To stop the bill, generate from 08/2024 onwards and withdraw the bill from 02/2021 to 08/2021. Against Cons no.9034-1202-4979.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
