GIST OF THE COMPLAINT:

The complainant consumer Sri Khageswar Sahu, At/Po- Bagpur, Ps- Narla, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Madanpur on dt. 23.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9034-1204-0065 under SDO Elect. Narla.
- 2) As complained by the complainant that to consider the excess amount bill served in the month of November 2021 and December 2021 and June 2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

3) Date of supply: 21/05/2008

4) Category: LT/Domestic

5) Connected Load 1 KW

6) Meter No - WLT219607



7) Installed on: 23.10.2021 with IMR: "0"8) CMR: 8260 KwH as on 29/10/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Narla as follows:

• In the present case the consumer meter was change on dated 23.10.2021. The average of six months consumption of new meter is 285 KwH. So this case the consumer bill will increase if we will revise from 07/2023 to 08/2021 by taking average of new meter. So in this case the bill may not revise.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that in the present case the consumer meter was change on dated 23.10.2021.
- As per billing database the bill was served in actual basis from 11/2021, after the meter change was effect. And bill revision towards defective period assessment was take in place on dtd. 19.02.2023, So no scope for bill revision.

ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

As the bill revision was already taken place, no further revision is required.

The case is disposed of accordingly. Case is hereby Dropped.
