GIST OF THE COMPLAINT:

The complainant consumer Sri Chudamani Sahoo, Repr. By Sri Ratnakr Sahoo, At-Jurkabhata, Po-Narla, Ps-Narla, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 18.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/DOM supply with CD of 1 KW having consumer no- 9034-1204-0434 under SDO Elect. Narla.
- 2) As complained by the complainant that some abnormal excess bill was served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 20/08/2025
- 2) Bill details from: 02/2001 to 07/2025
- 3) Date of supply: 01/01/1990
- 4) Category: LT/DOM
- 5) Connected Load 1 KW
- 6) Meter No LW605599
- 7) Installed on: 25/11/2020 with IMR "0"
- 8) CMR: 20229 KWH on 20/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As suppressed reading was billed 09/2023, we may recasd the bill from 11/020 to 07/2025 as IMR "0" KwH and FMR "20229" KwH. We may withdraw the earlier bill revision on dated 31.10.2023. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as suppressed reading was billed 09/2023, we may recasd the bill from 11/020 to 07/2025 as IMR "0" KwH and FMR "20229" KwH. We may withdraw the earlier bill revision on dated 31 10 2023
- Some bill was served abnormally from 11/2020 to 07/2025 due to supress meter reading.

ORDER 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 11/2020 to 07/2025 with IMR "0" KwH on 11/2020 and FMR "20229" KwH on 07/2025.
- Any bill revision done earlier during this period may be taken into consideration.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
