GIST OF THE COMPLAINT:

The complainant consumer Sri Shibprasad Bhoi, Repr. by Sri Debraj Bhoi, At/Po- Raksi, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 18.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9034-1205-0361** under SDO Elect. Narla.
- 2) As complained by the complainant the average bill was served from 04/2018 to 07/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 27/01/2025

- 2) Bill details from: 02/2015 to 12/2024
3) Date of supply: 08/02/2015
4) Category: LT/Domestic
5) Connected Load 1 KW
6) Meter No – WLT276357
7) Installed on: 07/11/2021 with IMR "0"
8) CMR: 1975 Kwh as on 27/01/2025
9) The meter status: Ok
10) Facts of the complainant: Revision of bill
11) As written version submitted by SDO Elect. Narla as follows:
- As per PVR given by the ESO, Narla the old meter was found defective.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR given by the ESO, Narla the old meter was found defective.
- As per billing database average bill was served from 04/2018 to 07/2022, and bill revision towards delay meter updating was take in place from 10/2021 to 07/2022 on 17.09.2022.

ORDER

31.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 10/2019 to 09/2021 by taking six months average consumption of present meter (i.e. IMR "668" Kwh on 09/2022 and FMR "1043" Kwh on 02/2023.
- To withdraw the DPS amount from 05/2020 to 03/2023 as it is a DOMESTIC category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
