GIST OF THE COMPLAINT:

The complainant consumer Sri Kichak Harpal, At-Pipalpadar, Ps-Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 17.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9034-1206-0438** under SDO Elect. Narla.
- 2) As complained by the complainant that excess bill was served in the month of 11/2020.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 19/03/2025
- 2) Bill details from: 07/2016 to 02/2025
- 3) Date of supply: 16.06.2016
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW



- 6) Meter No – 300042044
- 7) Installed on: 05/07/2023 with IMR "0"
- 8) CMR: 4779 KWH on 19/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - We may recast the bill from 06/2016 to 02/2023 by taking IMR "0" Kwh and FMR "8100" Kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that We may recast the bill from 06/2016 to 02/2023 by taking IMR "0" Kwh and FMR "8100" Kwh.
- As per billing database WUV09727 meter was installed from the date of supply but the reading was furnished as house locked and actual meter reading for some months. 3532 unit was billed in the month of 11/2020 for a month which seems to be suppress meter reading.

ORDER

29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 06/2016 to 02/2023 by taking IMR "0" on 06/2016 and FMR "8100" on 02/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 the opposite party after compliance otherwise it will be treated as non-compliance.
