GIST OF THE COMPLAINT:

The complainant consumer Sri Rajuram Rana, AT- Jhaliagobha, Po- Turki, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.05 KW having consumer no- 9034-1392-1710 under SDO Elect. Narla
- 2) As complained by the complainant that the excess abnormal bill was served in the month of August 2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 24/12/2024
- 2) Bill details from: 12/2019 to 11/2024
- 3) Date of supply: 10/08/2019
- 4) Category: LT/Domestic



- 5) Connected Load 0.05 KW
- 6) Meter No TW02024605
- 7) Installed on: 10/11/2022 with IMR: "0"
- 8) CMR: 1180 KwH as on 24/12/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
 - 1) As written version submitted by SDO Elect. Narla as follows:
 - As the consumer has billed suppressed units in the month of 08/2023, we may recast the reading from 11/2022 to 03/2024 i.e. IMR 0 KWH and FMR 927 KWH. The earlier bill revision to be withdrawn.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as the consumer has billed suppressed units in the month of 08/2023, we may recast the reading from 11/2022 to 03/2024 i.e. IMR 0 KWH and FMR 927 KWH. The earlier bill revision to be withdrawn.
- As per billing database the bill was raised in high consumption for the period 03/2023 to 09/2023, which seems supress meter reading. And the bill revision towards delay meter updating was take in place for the period 10/2022 to 02/2023, 10/2022 to 07/2023 & 10/2022 to 08/2023, effect on dtd. 24.03.2023, 10.09.2023 & 09.10.2023 respectively.

ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the earlier bill revision effect on dtd. 24.03.2023 and 10.09.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>January-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
