

GIST OF THE COMPLAINT:

The complainant consumer Sri Rohit Sahu, At-Indramal, Po-Chhatikuda, Ps-Narla, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 18,08,2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/GP supply with CD of 1 KW having consumer no- 9034-1501-1648 under SDO Elect. Narla.
- 2) As complained by the complainant that the consumer is availing power supply for agriculture purpose not for commercial purpose.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 26/08/2025
- 2) Bill details from: 04/2024 to 07/2025
- 3) Date of supply: 15/04/2024
- 4) Category: LT/GP
- 5) Connected Load 1 KW
- 6) Meter No TWSP51143310
- 7) Installed on: with IMR "0"
- 8) CMR: 966 KWH on 26/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR of the ESO, Chhatikuda the consumer is availing power supply as LT-IRR instead of LT-GP, in the site feasibility report it was mentioned as LT-IRR at the time-of-service connection release. The AO Ghantamal GP block Narla has also given certificate of using Agriculture purpose. So, we may change the category from the date

of power supply. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR of the ESO, Chhatikuda the consumer is availing
 power supply as LT-IRR instead of LT-GP, in the site feasibility report it was mentioned
 as LT-IRR at the time-of-service connection release. The AO Ghantamal GP block
 Narla has also given certificate of using Agriculture purpose. So, we may change the
 category from the date of power supply.
- The bill was served in LT-GP category from 04/2024, whereas the feasibility report was LT-Irrigation.

ORDER 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To change the category from LT-GP to LT-Irrigation from date of supply to till date as the complainant feasibility report was LT-Irrigation & revise the bill accordingly.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>September-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
