GIST OF THE COMPLAINT:

The complainant consumer Sri Bhuban Sahu, Repr. by Sri Kulamani Sahu, At-Burat, Po- Ghantmal, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 17.10.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.5 KW having consumer no-9034-1504-0478 under SDO Elect. Narla.
- 2) As complained by the complainant that the excess bill amount was served in the month of May-2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 29/10/2024
- 2) Bill details from: 01/2019 to 09/2024
- 3) Date of supply: 30/10/2018



- 4) Category: LT/Domestic
- 5) Connected Load 0.5 KW
- 6) Meter No TWST1803559
- 7) Installed on: 23/09/2024 with IMR: "0"
- 8) CMR: "12" KwH as on 29/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - We may recast the bill from 01/2019 to 07/2024 by taking IMR "0" KwH and FMR "4157" KwH. And we may revise in the month of 08/2024 by taking average of six months of new meter.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the bill may be recast from 01/2019 to 07/2024. And the bill may revise in the month of 08/2024 by taking average of six months of new meter.
- As per billing database the bill was raised in high consumption in the month of 05/2024, which seems supress meter reading. And in 08/2024 the bill was raised in average basis.

ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 10/2018 to 05/2024 with IMR "0" KwH on 10/2018 and FMR "4065" KwH on 05/2024.
- > To revise the bill for the month of 08/2024 by taking six months average consumption of new meter installed on 23.09.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
