GIST OF THE COMPLAINT:

The complainant consumer Sri Raghubir Nag, AT/Po- Biswanathpur, Ps-Biswanathpur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 27.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9034-2100-0513 under SDO Elect. Narla.
- 2) As complained by the complainant that the provisional/average bill was served from 11/2020 to 05/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla.) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 19/09/2024
- 2) Bill details from February 2013 to August 2024
- 3) Date of supply 02/02/2013



- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No TWSP51143893
- 7) Installed on 15/06/2024 with IMR: "0"
- 8) CMR: "39" KwH as on 19/09/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla. as follows:
 - As per the PVR given by ESO, Biswanathpur the meter is found OK and presently the power was disconnected. The consumer was billed as defective from 11/2022 to 05/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per the PVR given by ESO, Biswanathpur the meter is found OK and presently the power was disconnected. The consumer was billed as defective from 11/2022 to 05/2024.
- As per billing database some bill was recording in high consumption during the period 02/2013 to 10/2020.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To restore the power supply to the consumer premises by taking 50% of arrear amount along with reconnection fees as appropriate.
- To recast the bill from 02/2013 to 10/2020 with IMR "0" KWH on 02/2013 and FMR "9568" KWH as on 10/2020.
- To revise the bill from 06/2022 to 05/2024 by taking six months average consumption of new meter installed on 15.06.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
