GIST OF THE COMPLAINT:

The complainant consumer Smt Saraswati Sahu, Repr. By Smt Himandri Sahu, At-Dumermunda, Po/Ps-Biswanathpur, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 10.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- **9034-2100-1049** under SDO Elect. Narla
- 2) As complained by the complainant that excess bill was served in the month of 02/2017.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 24/02/2025
- 2) Bill details from: 06/2012 to 01/2025
- 3) Date of supply: 21/01/2012
- 4) Category: LT/Domestic



- 5) Connected Load 0.04 KW
- 6) Meter No – TWSP51033028
- 7) Installed on: 24/08/2023 with IMR "0"
- 8) CMR: 1194 KWH on 24/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the AOC, Biswanathpur the meter is found OK. The above consumer was not vailed the power supply from 09/2021 to 07/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the AOC, Biswanathpur the meter is found OK. The above consumer was not vailed the power supply from 09/2021 to 07/2023.
- As per billing database provisional and average bills were served from 09/2021 to 07/2023. and the consumer has also not deposited any amount during this period.
- The upward assessment raised from 08/2021 to 07/2023 after meter replace on dtd. 24.08.2023.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 09/2021 to 07/2023 as the consumer was not availed the power supply.
- Upward assessment raised during this period to be withdraw.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
