#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Harekrushna Joshi, Repr. by Sri Sashibhusan Joshi, AT- Herekrushnapur Po- Nangalbeda, Ps- Lanjigarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 27.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9034-2101-0598 under SDO Elect. Narla.
- 2) As complained by the complainant that the provisional bill was raised though the meter was working.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the provisional bill.

# SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 27/08/2024
- 2) Bill details from February 2001 to August 2024



- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No TWB151090
- 7) Installed on 31/08//2024 with IMR: "0"
- 8) CMR: 12164 KwH as on 27/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
  - As per the PVR given by the ESO Biswanathpiur the meter changed earlier was 04/12/2019, but in FG enter as 05/07/2021. Recently a new meter was changed vide no. TWB151090 dated 31/08/2024. The final meter reading of old meter was 9520 KWH but in PVR it was 12164 KWH.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per the PVR given by the ESO Biswanathpiur the meter changed earlier was 04/12/2019, but in FG enter as 05/07/2021. Recently a new meter was changed vide no. TWB151090 dated 31/08/2024. The final meter reading of old meter was 9520 KWH but in PVR it was 12164 KWH.
- As per billing database the bill revision was take in place for the period 07/2021 to 11/2023 and 07/2021 to 09/2022, effect on dtd. 20.11.2024 & 24.11.2022 respectively.

# ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 12/2019 to 07/2024 taking IMR "0" KwH on 12/2019 and FMR "12164" KwH on 07/2024.
- To withdraw the earlier bill revision was effect on 20/01/2024 on 24/11/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.


