- The complainant reiterated for excess billing. The OP stated that to revise the bill from 10/2021 to 09/2022 by taking six months average of new meter i.e. 12/2022 to 05/2023 as IMR 0 and FMR 404 KWH.
- As per billing database abnormal bill was raised from 10/2021 to 11/2022.

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To revise the bill from 10/2021 to 11/2022 by taking six months average consumption of present meter i.e IMR "0" KwH on 11/2022 and FMR "326" KwH on 04/2023.

The case is disposed of accordingly.
