GIST OF THE COMPLAINT:

The complainant consumer Sri Trinath Pradhani, At- Raghunathpur, Po-Nagalbeda Ps-Lanjigarh, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Lanjigarh on dt.10.01.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ DOM supply with CD of 0.04 KW having consumer No 9034-2101-1240 under SDO Elect.Narla.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

The complainant reiterated for false billing. The OP stated that the power supply was disconnected from 03/2022 but the meter reader was giving Actual meter reading till date.

ORDER 19.03.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 03/2022 to 12/2023. And reflect billing status as Bill Stopped in billing database.
- The complainant is directed to pay the arrear bill till 02/2022, and if wish to continue the same power supply to the same premises, to pay the requisite reconnection fees along with fix charges from 03/2022 to till date of reconnection.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
