GIST OF THE COMPLAINT:

The complainant consumer Sri Manuram Sahu, At- Harekrushnapur, Po- Nangalbeda, Ps-Lanjigarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 18.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9034-2101-1403** under SDO Elect. Narla.
- 2) As complained by the complainant that the bill was served in disconnection period from 04/2022 to 03/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 08/11/2024
- 2) Bill details from: 03/2021 to 10/2024
- 3) Date of supply: 15/11/2020
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWB645561



- 7) Installed on: 21/03/2024 with IMR: "0"
- 8) CMR: 783 Kwh as on 08/11/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the AOT, Bishwanathpur the consumer meter status is found OK. The consumer was not using the power supply from 04/2022 to 03/2024.
 - In the present case as the consumer had not used the power supply from 04/2022 to 03/2024, we may withdraw the same period except fixed charges as applicable.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR given by the AOT, Bishwanathpur the consumer meter status is found OK. The consumer was not using the power supply from 04/2022 to 03/2024.
- As per billing database average bill was served from 04/2022 to 03/2024 without power supply.

ORDER
29.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 04/2022 to 03/2024 excluding fix charges, as the consumer has not availed the power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
