GIST OF THE COMPLAINT:

The complainant consumer Sri Piwala Samant, Repr. By Sri Rajib Kumar Samant, At/Po-Kamada, Ps-Biswanathpur, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 10.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9034-2102-0414 under SDO Elect. Narla
- 2) As complained by the complainant that the excess bills amount was served in the month of 04/2016, 02/2019, 02/2023 and 11/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:


The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

1) PVR: 24/02/2025

2) Bill details from: 12/2006 to 01/2025

3) Date of supply: 30/12/2006

4) Category: LT/Domestic5) Connected Load 1 KW



7) Installed on: 22/07/2024 with IMR "0"

8) CMR: 1577 KWH on 24/02/2025

9) The meter status: OK

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Narla as follows:

 As the consumer was billed as suppressed reading, we may recast the bill from 11/2010 to 04/2024 by taking IMR 0 kwh and FMR 27796 kwh and we may cancel the previous bill revision on dated 13/12/2023 and 29/12/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as the consumer was billed as suppressed reading, we may recast the bill from 11/2010 to 04/20254 by taking IMR 0 kwh and FMR 27796 kwh and we may cancel the previous bill revision on dated 13/12/2023 and 29/12/2023.
- As per billing database the meter reading has furnished as premises locked and reading not taken for several months and very low consumption meter reading was furnished as actual meter reading but all of a sudden 9741 kwh was billed for a month of 02/2023 which seems to be suppressed meter reading.

ORDER 28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 11/2010 to 04/2024 by taking IMR "0" KWH on 11/2010 and FMR "27796" KWH on 04/2024.

To withdraw the revision entry on 13/12/2023 and 29/12/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
