The complainant consumer Sri Bikram Sahu repr. by Sri Milan Sahu, At- Pipalpadar, Po-Khamardha, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during the course of hearing at camp court at Biswanathpur on dt. 06.05.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9034-2102-1056 under SDO Elect. Narla.
- 2) As complained by the complainant abnormal was served in the month of 08/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that due to suppressed reading from 12/2018 to 11/2023 the abnormal bill was served.
- As per billing database some bill was served high unit consumption during the period from 12/2018 to 11/2023, which seems supress meter reading.

ORDER 31.05.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 12/2018 to 11/2023 with IMR "0" KwH on 12/2018 and FMR "6400" KwH on 11/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by June-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
