GIST OF THE COMPLAINT:

The complainant consumer Sri Kailash Chandra Behera, Repr. by Sri Santosh Kumar Behera, AT/Po- Lanjigarh Road, Ps- Narla, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 21.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9034-2107-0513** under SDO Elect. Narla.
- 2) As complained by the complainant that the provisional/average bill was raised from 11/2020 to 12/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

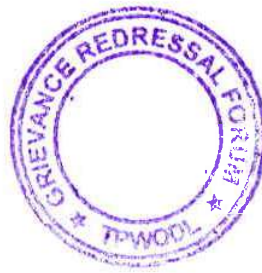
The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 05/10/2024
- 2) Bill details from October 2002 to September 2024



- 3) Date of supply 30/08/2002
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWB603509
- 7) Installed on 04/01/2024 with IMR: "0"
- 8) CMR: 37 Kwh as on 05/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the ESO Biswanathpur the defective bill should be revise should be revised from 01/2021 to 12/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per the PVR given by the ESO Biswanathpur the defective bill should be revise should be revised from 01/2021 to 12/2023.
- As per billing database provisional/defective bill was raised from 11/2020 to 12/2023.

ORDER

28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 01/2022 to 12/2023 taking six-month average consumption of present meter (I.e IMR "0" KWH on 01/2024 and FMR "21" KWH on 06/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
