#### GIST OF THE COMPLAINT:

The complainant consumer Sri Debendra Pradhan, At- Balabhadrapur, Po/Ps- Lanjigarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 06.05.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 1 KW having consumer no- 9034-2110-0280 under SDO Elect. Narla.
- 2) As complained by the complainant the category from LT/GP to LT/Domestic to be changed as the power supply is availing for domestic purpose.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.



 As per the report of the ESO, Biswanathpur the consumer is availing power supply in domestic purpose from 01/2020 to till date. So, we may revise the bill from 01/2020 to 03/2025 in domestic tariff and should change the category from commercial to domestic.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the report of the ESO, Biswanathpur the consumer is availing power supply in domestic purpose from 01/2020.
- As per billing database the bill has been served as LT/GP category from 04/2014, but the consumer has availed the power supply for domestic purpose.

**ORDER** 31.05.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To revise the bill from LT/GP to LT/Domestic from 01/2020 to 04/2025.
- To serve the bill in LT/Domestic category from 04/2025 onwards.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by June-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
