The complainant has prayed for:


To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that the Provisional bill has served from 05/2018 to 04/2022
- As per billing database the consumer was billed 6411 units in the month of 03/2016 and again 6511 units in month of 03/2017 as round complete.
- As per billing database the bill revision/adjustment towards delay meter updating has effect on dtd. 22.11.2022 & 20.12.2023.

ORDER 19.03.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 03/2016 to 03/2017 by taking average consumption from 07/2015 to 01/2016 with IMR "3412" KwH on 07/2015 and FMR "3589" KwH on 01/2016.
- To recast the bill from 04/2022 to 02/2024 with IMR "0" KwH on 04/2022 and FMR "468" on 02/2024.
- > To withdraw the earlier bill revision/adjustment towards delay meter updating was effect on dtd. 22.11.2022 & 20.12.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
