 - We may recast the bill from 03/2015 to 06/2024 by taking IMR "0" KWH and FMR

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the billing statement of the consumer was billed as 3297 units in the month of 06/2024 and that may be suppress reading.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 03/2015 to 06/2024 taking IMR "0" on 03/2015 and FMR "6097" as on 06/2024.

The case is disposed of accordingly.
