GIST OF THE COMPLAINT:

The complainant consumer Sri Mahendra Biswal, AT- Regidmal Po/Ps- Narla, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 09.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9034-2112-0546 under SDO Elect. No. II, Bhawanipatna.
- 2) As complained by the complainant that 2957 units was billed in the month of 06/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. No. II, Bhawanipatna) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 12/09/2024
- 2) Bill details from December 2002 to August 2024
- 3) Date of supply 12/11/2002
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW



7) Installed on 15/10/2022 with IMR: "0"

8) CMR: 3617 KwH as on 12/09/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. No. II, Bhawanipatna as follows:

• The consumer was billed an abnormal unit of 2957 in the month of 06/2024 and that may be suppressed reading.

• We may recast the bill from 11/2022 to 06/2024 by taking IMR 0 KWH and FMR 3412 KWH. The bill revision on dated 16/07/2024 is to be withdrawn.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that the consumer was billed an abnormal unit of 2957 in the month of 06/2024 and that may be suppressed reading.
- As per billing database 3412 units was billed in the month of 06/2024, which seems supress meter reading. And bill revision towards delay meter updating was affected on 16.07.2024 for the period 11/2022 to 05/2024.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 10/2022 to 06/2024 with IMR "0" KwH on 10/2022 and FMR "3412" KwH on 06/2024.
- To withdraw the bill revision amount effected on 16/07/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
