### **GIST OF THE COMPLAINT**:

The complainant consumer Sri Pabitra Harijan, Repr. by Repr. by Sri Gunanidhi Bag, AT- Mandiaguchha, Po- Dongri, Ps- Biswanathpur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 27.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9034-2113-0168 under SDO Elect. Narla.
- 2) The provisional bill has served though the meter is working, so the bill may be served as per meter reading.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla.) in its counter reply and course of hearing submitted as follows:

- 8) CMR: 102 KwH as on 06/09/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla. as follows:
  - As per the ledger available the consumer was billed as defective from 03/2022 to 02/2024.
  - So we may revise the bill from 03/2022 to 02/2024 by taking six-month average of new meter installed.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the ledger available the consumer was billed as defective from 03/2022 to 02/2024.
- So we may revise the bill from 02/2022 to 01/2024 by taking six-month average of new meter installed.

# ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

• To revise the bill from 02/2022 to 01/2024 taking six-month average consumption of new meter install on 28.02.2024 taking IMR '0" as on 02/2024 and FMR "102" as on 08/2024

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
