**GIST OF THE COMPLAINT:**

The complainant consumer Smt. Duti Majhi repr. by Sri Rama Chandra Majhi, At- Lumagaon, Po- Kumpkhal, Ps- Biswanathpur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 10.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9034-2113-0283** under SDO Elect. Narla
- 2) As complained by the complainant that excess average bills were charged during power supply without meter.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 24/02/2025
- 2) Bill details from: 02/2019 to 01/2025



- 3) Date of supply: 24/12/2018
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWB646140
- 7) Installed on: 30/03/2024 with IMR “0”
- 8) CMR: 599 KWH on 24/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
  - The defective bill from 12/2018 to 12/2019 may be revised by taking of six months of meter installed on dated 12/12/2019 i.e IMR 0 kwh on 12/2019 and FMR 25 kwh on 05/2020.

#### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the defective bill from 12/2018 to 12/2019 may be revised by taking of six months of meter installed on dated 12/12/2019 i.e IMR 0 kwh on 12/2019 and FMR 25 kwh on 05/2020.
- As per billing database the power supply was given without meter but the excess average bills were charged during this period.

#### **ORDER**

**28.02.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 12/2018 to 12/2019 by taking IMR “0” kwh on 12/2019 and FMR “25” kwh on 05/2020.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
