## **GIST OF THE COMPLAINT:**

The complainant consumer Sri Susil Harpal, At- Chandanpur, Po- Gopinathpur, Ps-Lanjigarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 21.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9034-2115-0359 under SDO Elect. Narla.
- 2) As complained by the complainant for withdraw bill amount during no supply period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 05/10/2024
- 2) Bill details from November 2018 to September 2024



3) Date of supply 16/11/2018

4) Category: LT/Domestic

5) Connected Load 1 KW

6) Meter No - TW02027532

7) Installed on: 19/12/2022 with IMR: "0"

8) CMR: 793 KwH as on 05/10/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

As written version submitted by SDO Elect. Narla as follows:

- As per the PVR given by the ESO Biswanathpur the power supply was given from 19/12/2022 and there is no power supply from 11/2018.
- So, we may withdraw the total bill from 11/2018 to 10/2022 as there is no such power supply was given to the consumer.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the ESO Biswanathpur the power supply was given from 19/12/2022 and there is no power supply from 11/2018.
- So, we may withdraw the total bill from 11/2018 to 10/2022 as there is no such power supply was given to the consumer.

 ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill amount excluding the fixed charges from 11/2018 to 11/2022 during the no power supply to the consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
