GIST OF THE COMPLAINT:

The complainant consumer Sri Suresh Chandra Maharana, At/Po- Bandhapari, Ps- Biswanathpur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 10.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9034-2116-0180** under SDO Elect. Narla
- 2) As complained by the complainant that excess bill was served in the month of 08/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

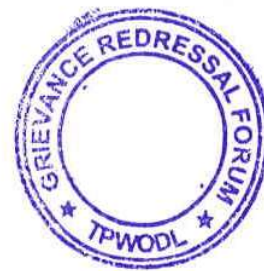
The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 24/02/2025
- 2) Bill details from: 10/2011 to 01/2025
- 3) Date of supply: 19/10/2011
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWB603546
- 7) Installed on: 16/01/2024 with IMR "0"



- 8) CMR: 431 KWH on 24/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - Bill to be recasted from 01/2015 to 08/2022 by taking IMR 0 kwh and FMR 5002 kwh.
 - The defective bill from 09/2022 to 12/2023 may be revise by taking average of six months of new meter installed i.e from 01/2024 to 06/2024 as IMR 0 kwh and FMR 237 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Bill to be recasted from 01/2015 to 08/2022 by taking IMR 0 kwh and FMR 5002 kwh.
- The defective bill from 09/2022 to 12/2023 may be revise by taking average of six months of new meter installed i.e from 01/2024 to 06/2024 as IMR 0 kwh and FMR 237 kwh.
- As per billing database the meter reading were submitted as provisional bills and actual meter reading for few months but 2780 kwh was billed in the month of 08/2022 which seems to be suppressed meter reading.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 01/2015 to 08/2022 by taking IMR "0" kwh on 01/2015 and FMR "5002" on 08/2022.
- To revise the bill from 09/2022 to 12/2023 by taking six-month average consumption of meter installed on 16/01/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
