GIST OF THE COMPLAINT:

The complainant consumer Sri Binayak Dalpati At/Po- Bandhapari, Ps- Biswanathpur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 10.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- 9034-2116-0234 under SDO Elect.
 Narla
- 2) As complained by the complainant that abnormal excess bill was served in the month of 08/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Narla as follows:

 As the consumer was billed as suppressed reading, we may recast the bill from 06/2015 to 08/2022 by taking IMR 0 kwh and FMR 5003 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as the consumer was billed as suppressed reading, we may recast the bill from 06/2015 to 08/2022 by taking IMR 0 kwh and FMR 5003 kwh.
- As per billing database the provisional bills were served several months and actual meter reading for few months. The reading was not taken properly .2778 units was billed in the month of 08/2022 which seems to be suppressed meter reading.

ORDER 28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 06/2015 to 08/2022 by taking IMR "0" kwh on 06/2015 and FMR "5003" kwh on 08/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
