GIST OF THE COMPLAINT:

The complainant consumer Sri Sadhu chandra Majhi, Repr. by Sri Chitra Majhi, At-Dangajore, Po-Bandhapani, Ps-Biswanathpur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 18.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9034-2116-0393 under SDO Elect. Narla.
- 2) As complained by the complainant abnormal excess bill was served in the month of 06/2021, 10/2021, 11/2021, 01/2022 & 07/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

1) PVR: 06/11/2024

2) Bill details from: 12/2018 to 10/2024

3) Date of supply: 12/12/2018

4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No TWB645789
- 7) Installed on: 28/03/2024 with IMR: "0"
- 8) CMR: 193 KwH as on 06/11/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the AOT, Biswanathpur the consumer meter status is found OK.
 - After details analysis from ledger, we may recast the bill from 12/2018 to 07/2022 by taking IMR 0 kwh and FMR 5004 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that As per the PVR given by the AOT, Biswanathpur the consumer meter status is found OK.
- As per billing database the provisional/high consumption bill was served from 07/2022, which seems supress meter reading. And the bill was served in average basis from 08/2022 to 03/2024 due to meter defective, And the bill revision towards defective period bill revision was take in place for the period 08/2022 to 02/2024.

ORDER 29.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 12/2018 to 07/2022 with IMR "0" KwH on 12/2018 and FMR "5004" KwH on 07/2022

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
