GIST OF THE COMPLAINT:

The complainant consumer Sri Ganesh Majhi, At- Dangajore, Po- Bandhapani, Ps-Biswanathpur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 18.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9034-2116-0394 under SDO Elect. Narla.
- 2) As complained by the complainant that the bill was raised in disconnection period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

1) PVR: 06/11/2024

2) Bill details from: 12/2018 to 09/2024

3) Date of supply: 12/12/2018

4) Category: LT/Domestic

5) Connected Load 1 KW

6) Meter No - WLT173224

7) Installed on: N/A



- 8) CMR: N/A
- 9) The meter status: No Meter
- 10) Facts of the complainant:
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - As per the PVR given by the AOT, Biswanathpur there is no power supply available
 at the consumer premises. But as per the ledger available with us, the consumer
 was billed as actual till 07/2022 after that the consumer was found defective.
 - So, we may recast the bill from 12/2018 to 07/2022 by taking IMR 0 kwh and FMR 5001 kwh. As there was no such specific date mentioned in the PVR for no power supply we may withdraw the bill from 08/2022 to 07/2024 except fixed charges.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- · The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the AOT, Biswanathpur there is no power supply available at the consumer premises. But as per the ledger available with us, the consumer was billed as actual till 07/2022 after that the consumer was found defective.
- As per billing database some bill was served in high consumption meter reading from 02/2021 to 07/2022, which seems supress meter reading. And the bill was served in average basis 08/2022 to 07/2024 & the bill was generated in "X" code from 08/2024 to 09/2024 and bill was stopped from 10/2024 onwards. DPS was levied from 10/2021 to 03/2023.

ORDER 29.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 12/2018 to 07/2022 with IMR "0" KwH on 12/2018 and FMR "5001" KwH on 07/2022.
- > To withdraw the bill amount from 08/2022 to 07/2024 as there was no power supply.
- To withdraw the DPS from 10/2021 to 03/2023.
- The complainant is directed to pay the balance outstanding arrear as per regulation 144 of conditions of supply code,2019 of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
