GIST OF THE COMPLAINT:

The complainant consumer Sri Jagar Majhi, At- Dangajore, Po- Bandhapani, Ps-Biswanathpur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Biswanathpur on dt. 18.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9034-2116-0406** under SDO Elect. Narla.
- 2) As complained by the complainant that the bill was raised in high consumption meter reading from 03/2022 to 12/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 06/11/2024
- 2) Bill details from: 12/2018 to 10/2024
- 3) Date of supply: 12/12/2018
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWB645788
- 7) Installed on: 28/03/2024 with IMR: "0"



- 8) CMR: 175 Kwh as on 06/11/2024
9) The meter status: Ok
10) Facts of the complainant: Revision of bill
11) As written version submitted by SDO Elect. Kesinga as follows:
- As per the PVR given by the AOT, Biswanathpur the consumer meter status is found OK.
 - After details analysis from ledger, we may recast the bill from 12/2018 to 08/2022 by taking IMR 0 kwh and FMR 2501 kwh and defective bill revision from 09/2022 to 02/2024 by taking new meter average from 03/2024 to 08/2024 i.e. 0 kwh and 146 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the AOT, Biswanathpur the consumer meter status is found OK.
- As per billing database the bill was served in high consumption meter reading from 03/2022 to 08/2022, which seems suppress meter reading. And the bill was served average basis from 09/2022 to 02/2024 & DPS was levied from 10/2021 to 03/2023.

ORDER

29.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 12/2018 to 08/2022 with IMR "0" Kwh on 12/2018 and FMR "2501" Kwh on 08/2022.
- To revise the bill from 09/2022 to 02/2024 by taking six-month average consumption of present meter (i.e. IMR "0" Kwh on 03/2024 and FMR "146" Kwh on 08/2024).
- To withdraw the DPS from 10/2021 to 03/2023 as the DPS not applicable to Domestic Category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
