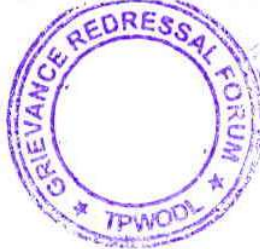

GIST OF THE COMPLAINT:

The complainant consumer Sri Birakishor Rana, AT/Po- Nunpur, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 19.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9034-2302-0350** under SDO Elect. Narla.
- 2) As complain by the complainant that the provisional/average bill was raised from 09/2018 to 03/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 04/10/2024
- 2) Bill details from October 2018 to September 2024
- 3) Date of supply 16/09/2018
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TW02034496
- 7) Installed on 09/02/2023 with IMR: "0"



- 8) CMR: 303 Kwh as on 04/10/2024
9) The meter status: Ok
10) Facts of the complainant: Revision of bill
11) As written version submitted by SDO Elect. Narla as follows:
- As per the PVR given by the ESO M. Rampur the meter installed on dated 01/2019 but it was updated in system 10/2021.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that as per the PVR given by the ESO M. Rampur the meter installed on dated 01/2019 but it was updated in system 10/2021.
- As per billing database provisional/average bill was raised from 10/2018 to 03/2021. And some bill was raised in high consumption from 04/2021 to 12/2022, which seems suppress meter reading.

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To recast the bill from 01/2019 to 12/2022 with IMR "0" Kwh on 01/2019 and FMR "1560" Kwh on 12/2022.
