GIST OF THE COMPLAINT:

The complainant consumer Smt Gela Parabhoi, At/Po-Nunpur, Ps-M. Rampur, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 11.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/DOM supply with CD of 1 KW having consumer no- **9034-2302-0382** under SDO Elect. Narla.
- 2) As complained by the complainant that average bill was served from 10/2018 to 01/2021 during no supply period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 14/08/2025
- 2) Bill details from: 06/2018 to 07/2025
- 3) Date of supply: 16/09/2018
- 4) Category: LT/DOM
- 5) Connected Load 1 KW
- 6) Meter No – TW02034175
- 7) Installed on: 10.02.2023 with IMR "0"
- 8) CMR: 1061 KWH on 14/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the field verification report given by ESO & SDO the consumer bill was generated, but power supply was not given from 09/2018 to 08/2020. So, we may withdraw the total bill generated from said period. However, the respondent requested the forum to take appropriate decision as necessary.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the field verification report given by ESO & SDO the consumer bill was generated, but power supply was not given from 09/2018 to 08/2020. So, we may withdraw the total bill generated from said period.
- From 09/2018 to 02/2021 average bills have been served.
- Meter No. TW02034175 had been installed on dt. 10.02.2023 and the CMR is 1061 KWH on 14/08/2025.

ORDER

30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 09/2018 to 08/2020 as power supply was not availed by the complainant.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
