**GIST OF THE COMPLAINT:**

The complainant consumer Sri Khedu Rana, Repr. By Sri Anil Rana, At-Jamabahali, Po/Ps-M. Rampur, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 11.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/DOM supply with CD of 1 KW having consumer no- **9034-2302-0661** under SDO Elect. Narla.
- 2) As complained by the complainant that average bills were served from 09/2018 to 09/2021 during no power supply period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 14/08/2025
- 2) Bill details from: 06/2018 to 06/2025
- 3) Date of supply: 28.07.2018
- 4) Category: LT/DOM
- 5) Connected Load 1 KW
- 6) Meter No – 300058055
- 7) Installed on: 16.06.2023 with IMR "0"
- 8) CMR: 596 KWH on 14/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
  - .As per field verification report given by ESO & SDO the consumer bill was generated, but power supply was not given from 07/2018 to 06/2020. So, we may withdraw the total bill generated from the said period. However, the respondent requested the forum to take appropriate decision as necessary.



### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per field verification report given by ESO & SDO the consumer bill was generated, but power supply was not given from 07/2018 to 06/2020. So, we may withdraw the total bill generated from the said period.
- From 07/2018 to 09/2021 provisional/ average bills have been served.
- Meter No. 300058055 had been installed on dt 16.06.2023 and CMR is 596 KWH on 14/08/2025.

### **ORDER**

**30.08.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 07/2018 to 06/2020 as the power supply was not availed by the complainant.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
