GIST OF THE COMPLAINT:

The complainant consumer Sri Nabin Kuimar Sahu, AT- Ainlapali, Po- Turchi, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 19.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9034-2303-0579 under SDO Elect. Narla.
- 2) As Complained by the complainant that Rs.30828.71 was wrongly added in bill was raised in the month of 03/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for: To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from July 2018 to May 2024
- 3) Date of supply 07/07/2018
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No WHL004795



7) Installed on 19/01/2022 with IMR: "0"

8) CMR: N/A

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Narla as follows:

As per the PVR given by the ESO M. Rampur an amount of RS. 30828.71 was wrongly debited as mis posting.

As there is no such data available and as per the report of ESO / SDO. We may withdraw the same amount of Rs.30828.71 which was debited in the month of 03/2021.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per the PVR given by the ESO M. Rampur an amount of RS. 30828.71 was wrongly debited as misposting.
- As per written version by the ESO/SDO there is no such data available regarding amount debited of Rs.30828.71 on the month of 03/2021.
- As per billing database Rs.30828.71 was debited in the month of 03/2021.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To restore the power supply immediately along with appropriate reconnection fees.
- To withdraw the sundry amount of Rs. 30828.71, which was debited on 03/2021.
- The complainant is directed to deposit the balance outstanding arrear along with reconnection fee as appropriate.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
