#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Budhabari Patra, At/Po- Urladani, Ps- M. Rampur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 19.09.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.04 KW having consumer no- 9034-2305-0619 under SDO Elect. Narla.
- 2) As complained by the complainant excess bill amount of Rs. 40238.90 was served for a month of 06/2023, which is very high.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

## SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect, Narla) in its counter reply and course of hearing submitted as follows:



- 1) PVR: 04/10/2024
- 2) Bill details from January 2022 to July 2024
- 3) Date of supply: 06/06/2019
- 4) Category: LT/Domestic
- 5) Connected Load 0.04 KW
- 6) Meter No TWB313798
- 7) Installed on: 19/03/2024 with IMR: "0"
- 8) CMR: 286 KwH as on 04/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill

As written version submitted by SDO Elect. Narla as follows:

- As per the PVR given by the ESO M. Rampur the old meter final reading was 710 KWH but it was updated in billing was 7010 KWH in the month of 06/2023.
- So, we may recast the bill from 07/2019 to 06/2023 by taking IMR 0 KWH and FMR 7010 KWH and the defective bill from 08/2023 to 02/2024 should be revised by taking average of six month of new meter reading.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the ESO M. Rampur the old meter final reading was 710 KWH but it was updated in billing was 7010 KWH in the month of 06/2023.
- So, we may recast the bill from 07/2019 to 06/2023 by taking IMR 0 KWH and FMR 7010 KWH and the defective bill from 08/2023 to 02/2024 should be revised by taking average of six month of new meter reading.

# o ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 06/2019 to 06/2023 taking IMF 0 KWH on 06/2019 and FMR 710 KWH on 06/2023.
- To revise the bill from 07/2023 to 03/2024 taking six-moth average consumption of new meter install on 19/03/2024 with IMR 71KWH on 04/2024 and FMR 301KWH on 09/2024.

The case is disposed of accordingly.
