FINDINGS / OBSERVATIONS OF THE FORUM

 The complainant reiterated for abnormal billing and DPS levied to him during the month from 10/2021 to 03/2023. The OP submitted that the bill for the month of 10/2021 was raised 69054 units amount of Rs 444151.52, and DPS was charged from 12/2021 to 03/2023 should be withdrawn.

ORDER 01.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To revise the bill for the month of 10/2021 by taking average consumption of the present meter (i.e. IMR "0" on 11/2021 and FMR "251" on 04/2021).
- > To withdraw the DPS levied during the month of 12/2021 to 03/2023.

The case is disposed of accordingly.
