GIST OF THE COMPLAINT:

The complainant consumer Smt. Nalita Majhi, Repr. by Sri Lakshamana Majhi, At- Dutta, Po-Salepali, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 06.06.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9034-2313-0423 under SDO Elect. Narla.
- 2) As complained by the complainant that the 1st bill was issued 5819 units on 01/2025.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 09/06/2025
- 2) Bill details from: 01/2025 to 05/2025
- 3) Date of supply: 27/03/2024 (As per FG)
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW

- 7) Installed on: 27/03/2024 with IMR "0"
- 8) CMR: 6115 KWH on 09/06/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR of ESO, M. Rampur the consumer was used the power supply from 01/03/2020 but supply date in FG is 27/03/2024, So we may recast from 03/2020 to 04/2025 by taking IMR 0 and FMR 6115 kwh.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per the PVR of ESO, M. Rampur the consumer was used the power supply from 01/03/2020 but supply date in FG is 27/03/2024.
- As per billing database the 1st bill was raised 5819 units in the month of 01/2025. Whereas
 the date of power supply was 01.03.2020.

ORDER 26.06.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 03/2020 to 05/2025 by taking IMR "0" KwH on 03/2020 and FMR "6115" KwH on 05/2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>July-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
