GIST OF THE COMPLAINT:

The complainant consumer Sri Gopiram Agrawal, Repr. by Sri Ankit Kumar Agrawal, At/Po- M. Rampur, Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Narla on dt. 21.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 2 KW having consumer no- 9034-2317-0040 under SDO Elect. Narla.
- 2) As complained by the complainant that the bill was raised after disconnection of power supply/.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 05/10/2024
- 2) Bill details from February 2001 to February 2024
- 3) Date of supply 01/01/1990



- 5) Connected Load 2 KW
- 6) Meter No WES03449
- 7) Installed on N/A
- 8) CMR: 8292 KwH as on 05/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
 - As per the PVR given by the ESO M. Rampur there is no such power supply and no meter found at the site. after inquiry the line was disconnected since 11/2021.
 - So, we may withdraw the total bill from 11/2021 to 07/2023 as the power supply was permanently disconnected.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that as per the PVR given by the ESO M. Rampur there is no such power supply and no meter found at the site, after inquiry the line was disconnected since 11/2021.
- As per billing database the provisional bill was raised from 11/2021 to 07/2023, and the bill generated in "X" code from 08/2023 to 02/2024.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 11/2021 to 07/2023 as the power supply was disconnected.
- The complainant is directed to pay the bill raised till 10/2021 and if wish to reconnect the same power supply to pay the fix charge from 11/2021 to 09/2024 along with reconnection fees as appropriate.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
