GIST OF THE COMPLAINT:

The complainant consumer Sri Ritesh Kumar Hota, At- Police pada, Po/Ps- M. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 06.06.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 1 KW having consumer no- 9034-2317-0152 under SDO Elect. Narla.
- 2) As complained by the complainant the average bill was served during disconnection period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 11) As written version submitted by SDO Elect, Narla as follows:
 - As per the PVR given by the ESO, M. Rampur the consumer power supply was disconnected from 06/2013 to 23/04/2025. So, we may withdraw the EC bill from 06/2013 to 03/2025 except fixed charges.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per the PVR given by the ESO, M. Rampur the consumer power supply was disconnected from 06/2013 to 23/04/2025.
- As per billing database the average bill was served from 06/2013 to 07/2023, and the complainant was disconnected from 08/2023 to 04/2025. And the above period was also certified by the Sarpanch M. Rampur GP.
- As per billing database the complainant was paid till 22.06.2014, it is construed that the power supply was availed by the complainant till 06/2014. And the line was disconnected from 07/2014 to 04/2025.

ORDER

26 06.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill from 07/2014 to 04/2025 excluding the fixed charges as the line was disconnected during the period.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by July-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
