**GIST OF THE COMPLAINT:**

The complainant consumer Sri Rohit Biswal, Repr. by Smt Madhabi Biswal, AT/Po-Mohangiri, Ps- Mohangiri, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at M. Rampur on dt. 20.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9034-2401-0138** under SDO Elect. Narla.
- 2) As complained by the complainant that some bill was raised in high consumption meter reading during the period from 02/2013 to 06/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Narla) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 23/12/2024
- 2) Bill details from: 12/2008 to 11/2024
- 3) Date of supply: 25/12/2008
- 4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No – TW02035831
- 7) Installed on: 09/07/2023 with IMR: "0"
- 8) CMR: 1497 Kwh as on 23/12/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Narla as follows:
  - As the consumer has billed suppressed units, we may recast the reading from the date of supply 02/2013 to 06/2022 i.e IMR "0" Kwh and FMR "2800" Kwh.

#### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that After verification from the ledger, it is found that and the following revision proposal to be done.
  - ✓ As the consumer was billed suppressed units from 02/2013 to 06/2022.
- As per billing database some bill was raised in high consumption meter reading from 02/2013 to 06/2022, which seems suppress meter reading.

#### **ORDER**

**06.01.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 02/2013 to 06/2022 with IMR "0" Kwh on 02/2013 and FMR "2800" Kwh on 06/2022.

The case is disposed of accordingly.
